2007 Bus Campaign - "Three To Get Ready"-

Target: Raise \$240,000 for three new handibus vehicles for the rural Calgary region

- Improve availability and cost-effectiveness of handibus transportation to the smaller communities of the Rocky View region (rural Calgary)
- Improve reliability of handibus service (fewer on-road failures)

Calgary's rural transportation demand is growing. The small town communities around Calgary are developing rapidly. Provincial policy initiatives regarding health care, children's services, education and seniors now emphasize a community-based approach to services. Access to these services often depends on a wheelchair accessible vehicle being available in the community.

Founded in 1980, Rocky View Regional Handibus transports seniors, adults, youth and children in five rural Calgary-region municipalities. Our operation has increased 40% since 2004. We take folks to school, dialysis, clinics, counselling, banking, therapy, groceries and more. The geography of our service region dictates long travelling distances. Our fleet of 8 buses is aging rapidly, travelling some 60,000 km per year. A trip into town for groceries or an appointment can be 40 kms (one-way), a specialist visit can be 85 kms.

Rocky View Handibus actively fund-raises about \$35,000 per year. Most of these funds are put towards repair of vehicles. Funding from municipalities is less than 10% of our operating budget. There is no direct provincial funding to operate a handibus in Alberta. Our research suggests that the Alberta Government would have to spend an additional \$500,000/ year if our vehicles were not available to help our rural passengers participate in provincial "care in the home" programs.

Our 2005 campaign raised two buses. **Associated Canadian Travellers**, **Nexen Energy**, **Nickle Family Foundation** and **Rotary Club of Calgary Olympic** each funded a quarter of a bus. We then matched these four donations with a Community Initiative Program grant (Alberta Lotteries). We had intended to repeat this format for 2007. Our goal was upgraded after one of our older vehicles was rear-ended (total loss & low salvage value). Equipment will go in service as soon as available funds become available. Replaced units will serve as spares for a 2 year period. We also intend to replace four more buses over the next two years.

Financial:

- A new bus costs \$80,000 and will save \$6,000 in fuel/maintenance costs in the first year of operation.
- Rocky View Regional Handibus will raise \$240,000 in donations and grants to acquire three buses
- The Community Initiative Program grant will match to a maximum of \$75,000

Status:

- Rocky View Regional Handibus seeks capital donations in amounts of: \$80,000, \$40,000, \$20,000, \$10,000 or smaller. Smaller donations will compile as a "Friends of Rocky View" recognition theme.
- Encana is our anchor donor for this campaign, contributing \$20,000 in November 2006

Return to the Community:

(From 2004 Report to Membership)

"One of the situations we frequently encounter regards transportation to post hospital therapies. Passengers often find themselves discharged early with physician instruction to return to the hospital for specialist therapy. Some experience total recovery and require only short-term transportation arrangements. Other passengers remain in long-term home-care programs. No one would be able to leave hospital early if transportation was not available for the follow-up therapies.

Using 2003 ridership data, we calculate that we facilitated the home-care of an equivalent of 2 adults for a full year (730 person days). If "care at home" facilitates a saving of \$400 per day over hospital stay, then Alberta Health was able to save almost \$290,000 in 2003.

Similarly, we identified another four rural seniors with need for occasional transportation. These Albertans were living in their homes but were unable to drive for various medical or family situations (e.g. spousal illness). Transportation for these families enabled four couples to stay out of a seniors residence for another year. The ministry responsible for housing (Alberta Seniors) thus saved about \$100 /day from this effort or about \$140,000 for the year.

We also transported 8-12 special needs preschoolers to development programs in Calgary. We estimate that our support of up to eight families helped Alberta Childrens Services save about \$120,000. The additional benefit of special needs children ready for Grade one (and less-likely to hold up the entire class) is much more difficult to calculate but does represent further long-term savings to Alberta Learning and the community at large.

These figures bear review by economists, however we identify over \$500,000 of support to Alberta Government policies and strategies in 2003. We assume this saving was repeated in 2004."

Note: We predict similar savings have been realized every year since we made this estimation.
